Cycling infrastructure upgrading	Top 30 areas for network upgrade were identified. NPDC are currently awaiting NZTA feedback. The RLTP that has been out for consultation has set aside \$1 million per year for three years. We are considering zoning, hit a big area with several treatments.	NZTA
	Coastal Walkway extension approved , the bridge is to be contractually completed and opened in March 2010. The extension route has been mapped and work will begin imminently. We should have a rideable route ready for the NZCC in November. Annual 150k cycle strategy implementation budget deferred until 2010/11. STC programme funding secure for 2009/10	Angela
