# Manawatu River - Te Matai/Staces Road Bridge

The bridge received many submissions, with roughly even numbers in support and in opposition. The Council carefully considered this issue and decided to leave the Te Matai bridge in the 10 Year Plan.

It is important to note that the Plan sets out Council's intention to build the new bridge at Te Matai subject to the Council receiving funding from the New Zealand Transport Agency (NZTA). This means it is subject to the outcomes of the joint strategic roading study to be undertaken with Horizons Regional Council, Manawatu District Council and NZTA, and subject to sufficient traffic flow projections to justify the NZTA funds. NZTA will not fund its share of the bridge if there is not enough projected traffic to justify it. In that case the bridge will not go ahead in the timeframes indicated in the 10 Year Plan.

While many more decisions that will affect the final approval for construction of a bridge still need to be made, inclusion of the bridge in the 10 Year Plan keeps Council's options open and helps protect central government funding contributions.

### Park Road / Cook Street - Roundabout Installation

Your support for this programme is welcome. The upgrade will complement the improvements to Cook Street which now facilitate movement across the City.
